The Greeks have two types of time: *chronos* and *kairos*. Life is a combination of routine (*chronos*) and unexpected moments of opportunity (*kairos*). This past year Five Acres has embraced the balance between following a steady plan and seizing opportunities for how we will move boldly into the future.

Over the years, as we have shared stories of past clients in our annual reports, there has been one theme. While each child was unique, they needed time in a steady and caring environment to get to a place where they could receive a loving family option. In 1888, helping to raise orphans until they were adopted was our way of ensuring that every child had safe, healthy, and permanent family solutions. Over the century, we have pivoted to figure out how we increase our impact on children toward our mission even as things shift around us. Whether it be a pandemic, a reform, or politics, how and when we seize the opportunities determines the bold moves we make for a brighter future.

This past year California Advancing and Innovating Medi-Cal – commonly known as CalAIM – took center stage with the vision to improve outcomes for the millions of Californians covered by Medi-Cal, including those with the most complex needs. California will allocate Medi-Cal funds to healthcare. Managed Healthcare will be required to link and contract with a range of non-traditional health and wellness agencies, like Five Acres. The non-traditional services include case management, housing support, peer support, and much more. The multi-year state reform had some regulatory changes to existing Five Acres services. More importantly, it gave us the opportunity to enter into new contracts and services with healthcare companies such as Anthem, LA Cares, Health Net, Molina, and CalOptima that align with our mission.

Once a child enters the foster care system, it becomes challenging work because they have already been traumatized, and permanency is more difficult to find. Over the past decades, we shifted our approach and pivoted toward expanding our prevention efforts, which means helping children who live with their families to stay together safely and avoid entering the foster care system. With the new opportunity under CalAIM, Five Acres is seizing the moment to diversify our funding streams and expand our prevention efforts and reach via healthcare contracts.

We are grateful to our hardworking team that have been maintaining our current services while simultaneously helping to expand services to our new healthcare population. Whether children are referred to us from the foster care system, or from the healthcare system, they are all coming to us because they are at risk due to safety, well-being, and permanency. From a child who is in foster care and experienced abuse and needs care and a safe haven, to a child who is suicidal with mental health challenges at risk of being removed from their home due to hospitalization, our goal remains the same for our Five Acres children – to have the unconditional love and safety that they deserve and need with a forever family. It is hard, challenging work. And when we discharge them, we sometimes hold our breath. We can feel exhausted. But, when we get occasional communications from former clients and hear how their stories turned out, we are reminded of the vital work we all do, including the role our generous donors play. Over time and in unexpected moments, we change lives.

In this annual report, you see how embracing *kairos* can lead to bold moves for advancing our mission. With your ongoing commitment to our journey, together we will continue to seize the opportunities for the children and families we serve.

Our Mission

Five Acres promotes safety, well-being and permanency for children and their families by building on their strengths and empowering them within communities.

Our Services

Since 1888, Five Acres has been supporting children and families within their communities. Today, we partner with families across Southern California to create a permanent, safe, and healthy environment for every child.

We offer a full range of behavioral health services at each of our many clinics, via telehealth, or by coming to you. We also offer comprehensive inpatient care for children who need 24/7 care.

We accept insurance from Anthem, CalOptima Health, Health Net, and Kaiser Permanente.

Residential

Every child should be raised by a loving family. Yet, when a child experiences acute trauma at home, living outside the home and within residential care is sometimes the best place to support children and families during the reunification process. At Five Acres, we provide short-term therapeutic residential care for these children to restore balance, rebuild trust and reunify them with their families or connect them to loving foster-adopt families.

Prevention

Preventing children from entering the foster care system is key to curbing Southern California's growing foster care and homelessness crisis. Five Acres' prevention services support families in the community by sending mental health and behavioral health specialists into the homes of children, youth and families.

Permanency

Five Acres actively strives to provide stability by connecting children to safe, permanent, and loving families. Our permanency services create loving homes for children in need through foster care, adoption and mentor support for families going through the adoption process. Through Adoption Promotion Support Services, we support children and adoptive families to nurture lifetime commitments.

Community Based Services


Through our Community Based Services, we provide behavioral support, skill building, and counseling to children and youth who are experiencing risk factors or stressors that cause disruptions in their home, school, relationships, and communities. We also provide support to parents, caregivers, and families to improve relationships, develop skill sets, and cope with symptoms in a positive and safe way. While our staff provide traditional mental health services, our Community Based Specialty Division also focuses on specialized preventative and early intervention services to keep children safely in the home and improve the overall quality of life for the children and families we serve. In addition, our Deaf Services remains the only provider of community-based counseling to individuals who are deaf in Los Angeles County.

Private Health Care Services

We partner with private health care organizations across Southern California to provide access to intensive services for children to keep them safe in their own home and community. Through our care, we help lower the child's risk of psychiatric hospitalization and reduce the need for out-of-home congregate care placements.

Agency Client Impact Age in Years










Seizing Opportunities For Safety



In the fiscal year 2022-2023, Five Acres continued its longstanding commitment to enhancing the safety, well-being, and permanency for children and their families, marking 135 years of dedicated service. Our focus on data-driven decision-making and evidence-based practices has been more critical than ever. With the establishment of the Zeilstra Research and Training Center and the implementation of an agency-wide Evidence-Based Practices (EBP) culture, we have solidified our position at the forefront of child and family services.

Key findings highlighted the persistent challenges faced by children and adolescents, particularly in the realms of mental health and safety. Drawing from the Youth Risk Behavior Surveillance System, we've observed troubling trends in mental health, with increases in feelings of sadness, hopelessness, and suicidal behavior among youth, like Annie, who was 11 years old. She displayed suicidal ideations when angry or frustrated. Having experienced 12 out-of-home placements within seven months, Annie was admitted to Five Acres. These issues underscore the urgency of our mission and the importance of our work to create safe environments for the children and youth we serve.

With no family support or involvement, Annie's court-appointed special advocate worked tirelessly for her educational needs and consistently visited. Annie had developmental delays and was diagnosed with diabetes. She also had an individual education plan to assist with her unique educational needs. While at Five Acres, Annie received individual therapy, group therapy, rehabilitation services, psychiatric support, Therapeutic Behavioral Services, and case management. On the adoption track with the Department of Child and Family Services, Annie attended many adoption events in search of a loving family. Through our innovative approaches and commitment to excellence, Five Acres' conscientious team has impacted Annie's life and that of 6,166 individuals this past fiscal year, with a significant portion of our clients being children under the age of 12 experiencing mood disorders and depression.

Besides our short-term residential therapeutic program, our efforts in providing specialized outpatient programs have addressed critical safety concerns, including decision-making, suicide risk and non-suicidal self-injurious behavior. Our team believed that Annie could benefit from individualized identified specific services that Regional Centers offer. Annie was initially denied twice. Our team continued to advocate for Annie, and after almost two years of being persistent, Annie was finally approved for Regional Center Services that would provide her with additional services and resources she needed to succeed.



Annie's team worked diligently in reducing her behavioral challenges by providing Annie with skills and tools to utilize during challenging times. Open to treatment and gaining the tools she needed to decrease or stop the maladaptive behaviors she was displaying, Annie was successfully discharged after two years of being at Five Acres to a foster home.

As we reflect on the past fiscal year, we are reminded of the importance of our mission and the need for bold moves to support the children and families we serve. Our journey is far from over as we continue to make strides towards a brighter future for all.

Seizing Opportunities For Well-Being



Maria watched her daughter, Nancy, with a mix of concern and hope for what she knew was possible with the right support. At just 14 years old, Nancy had already faced battles that would test the resilience of someone twice her age. The onset of self-harm at 11 and a heartrending suicide attempt three years later were the harrowing lows in Nancy's young life. It was a period marked by depression, self-harm, and suicidal thoughts that left her grappling with motivation, struggling at school, and straining family relationships.

The Five Acres team, under the watchful guidance of Karina Ramos, the director of Private Healthcare, became their lifeline. They were introduced to the community-based mental health services through the Kaiser Wraparound Contract, an initiative that has touched over a thousand lives across various cities.

When Nancy participated in the Wraparound Program, it was a race against time to construct a robust safety net around her. The team tailored a treatment plan that addressed the intricate web of challenges Nancy faced. A clinician helped her understand the importance of medication and communication with her psychiatrist, navigating through the family's

cultural beliefs about medical treatment. Family therapy sessions became a haven for resolution and understanding, fortifying the bonds that had weakened under the strain of Nancy's condition.

A behavioral specialist and case manager brought their expertise to the forefront, helping Nancy reintegrate into school life and leveraging her father's support in a pivotal role. The case manager, alongside Maria, worked tirelessly to secure resources and educational support, ensuring that Nancy's academic journey did not falter due to her mental health challenges.

The transformation was profound. Within five months, Nancy had met all her treatment goals. She found strength in her vulnerability, channeling it into advocacy for her younger brother's mental health needs. Now, Nancy walks the halls of the same high school her mother proudly works

at and once graduated from, not just surviving but thriving.

Maria and Nancy's journey is a testament to the power of bold moves for dedicated care given by our team and the resilience of the human spirit in creating a bright future.



Seizing Opportunities For Permanency



Our Five Acres team works to provide loving, forever families for children and youth awaiting adoption. The journey to adoption is often a testament to the power of love and commitment, which is vividly exemplified by Kailany's and Mateo's stories.

In a heartfelt culmination of nearly three years of nurturing care, Alana Gentry and Erich Schneider officially welcomed Kailany into their family in October 2023 when their adoption was finalized. Since being placed with them in January 2021, Kailany has thrived under their attentive guardianship, enveloped in a loving and caring environment that has fostered reunification. Alana has been supportive of our permanency efforts by hosting support groups. Kailany has developed a love of music, the outdoors, and is creative. Seizing the opportunity to create a loving and forever home, Alana and Erich have ensured Kailany's journey to adoption is a story of joy and endless possibilities.

After overcoming tremendous challenges, Mateo has found a forever home with Eduardo Ruedas and Anthony Hurtado, following a 13-month journey through foster care. Escaping a past marked by severe abuse, Mateo has flourished with the unwavering support of his resource parents. Our intensive therapeutic services and a consistent mental health team have transformed his initial behavioral challenges into remarkable progress. Eduardo and Anthony are now navigating the path to secure Mateo's citizenship, a testament to their

dedication to his well-being. Mateo's integration into the family and bond with their extended kin highlights the resilience and transformative power of love and care in healing and making his future bright.

Overcoming adversity and embracing new beginnings are often overwhelming for everyone involved in the adoption process. Through consistent support and dedicated therapeutic interventions, our teams have seized opportunities to turn trials into triumphs. Kailany and Mateo and their respective families now see brighter futures.


